## Who Should Attend?

- Understand the relationship between principles, processes, themes, products and roles within a PRINCE2 project.

## Case Study Sessions

Case study sessions and discussions based on your organisation's actual current projects are used throughout the course. This reinforces the learning process and gives participants a practical way to look at how PRINCE2 can be used in their own workplace.

## Exam

The PRINCE2 In-Practice Course gives participants the required knowledge to sit the PRINCE2 Foundation Exam. This can be scheduled for the last day of the course, during a separate session (recommended) or not at all. We will work with you to find an option that suits your needs.

### Exam format:

- Multiple choice
- 60 questions per paper
- 33 marks required to pass (out of 60 available) - 55%
- 60 minutes duration
- Closed book.

## Workplace Implementation Support
