Who Should Attend?

This course is designed for project management professionals who have already taken and passed their PRINCE2 7 Foundation Exam; and who require the internationally recognised PRINCE2 registered practitioner status.

Course Prerequisites

In order to sit the PRINCE2 Practitioner exam you must provide proof of having passed one of the following:

- PRINCE2 7 Foundation,
- PRINCE2 6 Foundation or Practitioner,
- Project Management Qualification (PMQ), Project Professional Qualification (PPQ), Project Management Professional (PMP), CAPM, or IPMA (Levels A, B, C or D).

You can still attend the PRINCE2 Practitioner Course, however you will not be permitted to sit the exam until you provide proof of one of the above.

Course Objectives

- Understand how to apply PRINCE2 to a specific project.
- Know how to use the PRINCE2 manual effectively.
- Understand and have experience in answering the different styles of questions used in a PRINCE2 practitioner exam.

Exam

The course fee includes an opportunity to sit the PRINCE2 Practitioner Exam. The exam is offered online and can be scheduled at a time where you feel best prepared. This allows you to focus your attention on learning without having the pressure of having to sit the exam.

Exam format:

- Objective testing
- 70 questions per paper
- 42 marks or more required to pass (out of 70 available) - 60%
- Two-and-a-half hours (150 minutes) duration, no additional reading time
- Open book exam (official PRINCE2 manual only).
